

Privacy Policy

This Privacy Policy describes how EARNERS HUB ("we," "us," or "our") collects, uses, and discloses your personal information when you use our website (the "Website") and the services we offer (the "Services").

1. Information We Collect

We collect a variety of information about you when you use the Website and Services. This information can be categorized as follows:

- **Personal Information:** This information can be used to identify you as an individual and may include:
 - o Name
 - o Email address
 - o Phone number
 - o Date of birth
 - Government-issued ID (for verification purposes)
 - Payment information (such as credit card or bank account details)
 - o IP address
 - o Geolocation data
- Non-Personal Information: This information does not identify you as an individual and may include:

2. How We Collect Information

agreed to comply with strict data security and privacy requirements.

We may also disclose your information if we are required to do so by law or in the good faith belief that such disclosure is necessary to comply with a court order, subpoena, or other legal process, or to protect the rights, property, or safety of us or others.

5. Your Choices

You have a number of choices regarding your information:

- Access and Correction: You have the right to access and correct your personal information. You can review and update your personal information by logging into your account on the Website.
- Marketing Communications: You can opt out of receiving marketing communications from us by following the unsubscribe instructions in the emails we send you.
- Cookies: You can control how cookies are used on your device by adjusting your browser settings.

6. Data Security

We take the security of your information very seriously. We use a variety of security measures to protect your information, including:

- Secure Socket Layer (SSL) encryption to protect your information during transmission
- Firewalls to protect our servers from unauthorized access
- Regular security audits to identify and address potential vulnerabilities

However, no website or internet transmission is completely secure. We cannot guarantee the security of your information.

7. Children's Privacy

The Website and Services are not directed to children under the age of 18. We do not knowingly collect personal information from children under the age of 18. If you are a parent or guardian and you believe that your child has provided us with personal information, please contact us. If we learn that we have

collected personal information from a child under the age of 18, we will delete that information from our systems.

8. International Transfers

Your information may be transferred to and processed in countries outside of your own country. These countries may have different data protection laws than your own country. However, we will take steps to ensure that your information is treated securely and in accordance with this Privacy Policy. Whenever we transfer your information to a third-party service provider or partner in another country, we will ensure that appropriate safeguards are in place, such as standard contractual clauses approved by the European Commission or other relevant regulatory body.

9. Data Retention

We will retain your information for as long as necessary to fulfill the purposes for which it was collected, as set out in this Privacy Policy. In some cases, we may be required by law to retain your information for a longer period. When we no longer need to retain your information, we will securely delete it or anonymize it.

1 0. Your Rights

Depending on your location, you may have certain rights under data protection laws. These rights may include the right to:

- · Access your personal information
- Correct your personal information
- Delete your personal information
- Restrict the processing of your personal information
- Object to the processing of your personal information
- Request a copy of your personal information in a machinereadable format
